- To pursue the best possible outcome within the time agreed upon and in compliance to the law;
- To extend these services for an additional period of time if necessary.

Notice. This contract is solely between the Contractor and the client(s). The selling dealer, _____ is not a party to this agreement and makes no representations or warranties concerning the services provided or to be provided.

Additional Terms and Conditions

Service Warranty. The Lifetime Membership Fee is non-refundable. In the event the Client becomes dissatisfied with GENESIS, all other fees are refundable upon fulfillment of the following conditions:

- (1) Client must notify GENESIS regarding all credit issues, both past and present;
- (2) Client must provide GENESIS with full documentation as outlined in the GENESIS "Client Checklist;"
- (3) Client must not have their credit 'pulled' without first speaking with a GENESIS Consultant;
- (4) Client must abide by all instruction set forth in the GENESIS "Client Do's and Don'ts";
- (5) Client must contact a GENESIS Consultant prior to entering into any agreement or performing any act which would result in an inquiry into the Client's credit;
- (6) Client must provide up-to-date documentation on all new or changed credit items.

Limited Power of Attorney. I/We appoint GENESIS and GENESIS' own legal representatives as my/our true and lawful legal counsel in fact, and in person, with full power and authority to represent me, in the following limited activities:

- (a) To handle any and all matters relevant to my credit reports with any credit bureau.
- (b) To create and/or cause additions, deletions, or corrections to my credit report with any credit bureau.
- (c) To review any and all documents in the possession of the credit bureau to which I have legal access.
- (d) To handle any and all matters relevant to my credit with any of my creditors and/or financial institutions.
- (e) In the employment of other professionals to assist GENESIS/Client to accomplish requests and limited activities.
- (f) To correspond with all credit reporting agencies directly as though we were the client.
- (g) To question and audit any information on the credit report.
- (h) To receive correspondence from all credit related entities to a convenient and more efficient address used by GENESIS for auditing purposes only.

Client Obligations. Client hereby agrees to following requirements:

- (1) Client will forward each credit report to GENESIS AS SOON AS IT IS RECEIVED;
- (2) Client will forward any credit bureau or creditor correspondence;
- (3) Client will contact GENESIS for credit information or to answer any questions;
